AN ACT TO AMEND THE PROCUREMENT ACT 2019

Commencement

Made by the Maneaba ni Maungatabu and assented to by the Beretitenti

1. Short Title

This Act may be cited as the *Procurement (Amendment) Act 2021*.

2. Meaning of 'principal Act'

In this Act the Principal Act means the *Procurement Act 2019*.

3. Amendment of section 3

Section 3 is amended as follows:

- (a) by changing the definition of 'Chief Procurement Officer' to the following-
"Chief Procurement Officer" means the Secretary responsible for Finance;
- (b) by inserting a new definition immediately before 'Services' as follows-
"Senior Procurement Officer" means the officer appointed in accordance with section 99 of the Constitution and as further detailed in Section 15".

4. Amendment of section 15

Section 15 is amended by deleting the word 'Chief' as appears in the title, subsection (1) and (2) and replacing it with the word "Senior".

5. Amendment of section 17

Section 17(2)(f) is repealed and substituted with the following: -

"A Senior Procurement Officer shall be tasked with the role of secretariat of the Board".

6. Amendment of section 18

Section 18(2) is amended as follows:-

(1) In paragraph (a) by repealing it and substituted with the following-

"(a) The Procuring Entity Procuring Officer shall be tasked with the coordination of the work and to act as chairperson"

(2) In paragraph (d) by repealing it and substituted with the following-

"(d) A Senior Procurement Officer shall be tasked as the secretary of the committee."

7. Insertion of a new section 39A

Part IX of the principal Act is amended by inserting a new section 39A as follows:

"39A Act binding

This Act shall bind all State Owned Enterprises (SOEs), statutory body corporations/authorities and the lists of these bodies together with the procurement process are to be prescribed by Regulations".

THE PROCUREMENT (AMENDMENT) ACT 2021

EXPLANATORY MEMORANDUM

The main purpose of this Amendment Act is to change the title and role of the Chief Procurement Officer to allow more efficiency in the procurement process. The title of the Chief Procurement Officer is now changed to Senior Procurement Officer while the title Chief Procurement Officer is transferred to the SRO or the Secretary for Finance. The role of the Senior Procurement Officer is also limited to only being the Secretariat for both the Board (section 17) and the Committees (Section 18). The Procuring Entity Officer shall be tasked with the Chairperson of the Procuring Committees for the concerned entity. There is also a new insertion-39A which binds all Government owned companies and statutory corporations to this act.
